

Distribution Report of NFIs for recent 318 conflict affected (IDPs) families in Lashkargha City of Hilmand province

Outline of the report

The conflict in northern districts of Helmand (Nawzad, Musa Qala, Sangin, Kajiki and NahriSiraj) the displacement continued till middle of August. A number of civilians fled their places of origin, majority moved to Lashkar Gah (318 families/2390 individuals), and Kandahar province. Some families reported arrived without household items and settled with their friends/relatives while some families settled in destroyed governmental buildings.

So the joint assessment conducted by DoRR Helmand, WFP, ANDAMA Helmand HAPA, APA, OHW, UNHCR. Governor Hilmand. Representatives

So the Findings derived from interviews conducted through home visits with 318 families in different locations of displacement in Lashkargah city

According to the report The Living conditions of IDPs were The IDP families lived with relatives/friends as well as tribesmen while some families rented houses. Few families found lived in destroyed buildings

So the reported that All the displaced families needed Food and Non-food items assistance The total displaced populations are 2390 persons {(male 1143 (48%) and female 1247 (52% including children less than 5 years of age 21%)} Please see the below table

So according the needs of mentioned IDPs UNIEF released NFIS (Sweaters, Family kits and Collapsible Water Container) for recent 318 conflict affected (IDPs) families in Lashkargha City of Hilmand province

According to the rule and regulation the distribution of NFIs Started on Date 06/09/2014 for recent conflict affected (IDPs) families in Helmand Lashgargha City

And completed on date 14/09/2014

During the distribution process the following representatives were present:

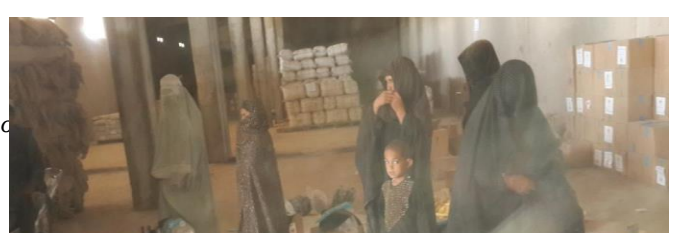
